



## Kids FarmSafe Week Colouring Contest Rules

The Canadian Agricultural Safety Association (CASA) is offering this Colouring Contest in partnership with BASF Agricultural Solutions Canada Inc.

By participating in this Contest, the child or youth's legal parent/guardian is agreeing to the Contest rules and terms and conditions as outlined below.

### Contest Dates

The Colouring Contest begins May 1<sup>st</sup>, 2026 and closes at 11 p.m. Central Daylight Time (CDT) on May 31<sup>st</sup>, 2026.

### Eligibility

The contest is open to children and youth ages 3 to 13. One (1) entry per person. The Colouring Contest is not available to residents of Quebec.

### How to Enter

Print out the page and colour it.

b. By entering the Contest, you agree to let CASA post the submitted artwork on Facebook and Instagram (personal information will be kept anonymous) and you accept the terms and conditions of the Contest.

c. Be sure to include the following information with your entry: child's name and age, and a parent or guardian's phone number or e-mail address so that winners may be notified.

d. Contest ends on May 31<sup>st</sup>, 2026 at 11 p.m. Central Daylight Time (CDT).

### Winners & Prizes

Five entries will be selected as winners of this Contest. Entries will be selected at the Contest's end by CASA.

Winners will be notified by email or phone.

Each winner will receive a Visa gift card and BASF swag.
